		Learned counsel for the petitioner would submit	

that petitioner is a medical practitioner registered with Chhattisgarh Medical Council. He has done reguisite training in Ultra Sound with registered institute and experience certificate to this effect was also issued in his favour. Respondents vide Notification dated 9.5.2022 issued advertisement conducting for Competency Based Examination, 2022 (Third Attempt). Petitioner submitted his application form along with requisite fee to appear in said exam. After evaluation of application form submitted by petitioner, he was declared 'ineligible' vide Annexure P-1 on 18.5.2022. Grounds on which petitioner has been declared ineligible are not sustainable. There is no clause in the advertisement that name of a candidate is to be received from the office of the District Chief Medical and Health Officer. Second ground for declaring petitioner ineligible is also not sustainable in view of documents annexed along with writ petition. This is last examination to be conducted by respondents; if the petitioner is not permitted to appear in it, the same will badly affect his professional career. Hence, pending hearing of this petition, petitioner may be permitted to appear in the examination which is going to be held on 23.5.2022.



On instructions, learned State Counsel submits that experience certificate annexed along with writ petition is not issued by a recognized institute, hence respondents are justified in declaring petitioner to be ineligible to appear in exam.

Perusal of Annexure P-1 would show that reasons assigned for declaring petitioner to be ineligible are that name of petitioner is not received from the office of the District Chief Medical and Health Officer; and petitioner is not registered anywhere in the State of Chhattisgarh. Submission of learned State Counsel is not in consonance with the reasons assigned in Annexure P-1 for declaring petitioner to be ineligible.

Taking into consideration facts and circumstances of the case, particularly the fact that Competency Based Examination, 2022 is scheduled on 23.5.2022, pending hearing of this writ petition after submission of detailed reply by learned counsel for the State, it is directed that respondents shall permit the petitioner to appear in Competency Based Examination, 2022 scheduled to be held on 23.5.2022. It is also directed that result of petitioner will not be declared till next date of hearing. It is made clear that petitioner will not claim any right if he fails to succeed in writ petition only on the basis of his participation in Competency Based Examination, 2022.
